Meeting Called to Order at 6:30 PM by Tom Brunner

<u>Secretary's Report:</u> Motion by Tom Brunner to approve January Minutes as submitted. Second, by Craig Brown. Vote taken, no opposition. Motion passed. Minutes approved.

Treasurer's Report Greg Glazner:

Greg reported that 2 CDAR's more than \$40,000 matures effective 3-1-25 and that 1 CDAR in the amount \$58,000 matures effective 3-7-25.
