Meeting Called to Order at 6:31 PM by Tom Brunner.

<u>Secretary's Report:</u> Motion by Tom Brunner to approve November Minutes as submitted. Seconded by Ray Faccenda. Vote taken, no opposition. Motion passed. Minutes approved.

Homeowner's Forum:

Russ Field inquired about the status of the geese in the parks. The response was action has been deferred to early 2025.

The benches at Treasure Island were discussed. No action to report currently.

Presidents Report {Tom Brunner}:

Discussed the need to replace the heating unit at the HOA offices. Bids are currently being procured so that the next steps can be determined reference the price and scope of the needed work.

Treasurer's Report {Greg Glazner}:

There were no questions regarding the as of 11-30-24 HOA financials.

Payment consideration of the remaining approximate \$19,000 cost to replace Treasure Island Park benches is awaiting a response on the transfer of two benches.

Discussion took place regarding the proposed financial control document. The acceptable number of contractor bids is changed from 3 to 2 and it was decided that insurance and contract controls should not be included in the financial control document.



A vote on the acceptance of the financial controls as stated in "Version 5" was proposed by Tom Brunner and seconded by Greg Glazner. Vote was taken, no opposition. Motion passed.

The surplus sound system owned by the HOA will be sold.

No transfer from the reserve fund will be needed to pay the remaining balance on the park bench replacements. Payment will be made sometime in 2025.

The transition from a cash to a modified accrual accounting system was discussed. The switch was recommended by Greg Glazner. A vote was taken, no opposition. The motion passed and starting in 2025 the board will switch to a modified accrual accounting system.

PM Report:

- 1. Natasha Tanev will be the new front desk person.
- 2. There has been interest in the open board positions and applications will be sent to the prospective applicants.

The Division 3 home with the insufficient street setback was discussed. A vote was
taken on whether the homeowner should be required to modify the fence so that
the construction of the same complies with the setback specification. A vote was
taken. The vote was 6-1 in favor of requiring the homeowner comply with the
setback requirement.
